

END-USER LICENSE AGREEMENT

CORPORATE TRAINING TECHNOLOGIES, INC. END-USER SOFTWARE LICENSE AGREEMENT

IMPORTANT- READ CAREFULLY: This End-User Software License Agreement (the "Agreement") is a legal agreement between you and Corporate Training Technologies, Inc. ("CTT") for use of the Software product identified on Exhibit A attached hereto which includes computer software and associated media and printed and electronic materials (collectively, the "Software"). By downloading, installing, copying, accessing or otherwise using the Software, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, discontinue use of the Software and promptly return the unused Software to the distributor from whom you purchased the Software. The Software is the property of CTT or its licensors and is protected by copyright law. While CTT continues to own the Software, you will have certain rights to use the Software after your acceptance of this Agreement. Except as may be modified by a license addendum which accompanies this Agreement, your rights and obligations with respect to the use of this Software are as follows:

1. Grant of License. CTT grants you a non-exclusive non-transferable license for those educational software modules listed on Exhibit A attached hereto, or as may be supplemented by CTT in writing from time to time, and any associated media, printed and electronic materials. If you have paid for and been granted a Single-User License, you can only use one copy of the Software on a single PC at any one time, and you may make one copy of the Software solely for back-up purposes. If you have paid for and been granted a Workgroup Server License you may install and use the Software on a single client server system at any one time. If you have purchased a Workgroup Server License you may allow access to the Software on the client-server by any number of persons who are your employees during the term of this Agreement. If you are accessing Content under the General BCG License, you may allow access to the Software on the internet by up to a maximum of 20 persons who are your employees during the term of that License. You will receive a set of access codes which, when entered on CTT's website will allow access to the Software on the website by persons who are your employees. You agree not to disclose these access numbers to third parties. The General BCG License shall be effective for so long as you are a member of the Bankers' Compliance Group ("BCG"), but shall terminate if you cease to be a member of BCG. Licenses granted for software modules other than those covered by the General BCG License shall be effective for one year (or such longer or shorter period of time as may be specifically agreed to by CTT) and shall: (i) cover such supplemental modules as are agreed to by CTT (as shown below, or as otherwise agreed to by CTT); (ii) allow access to seats in the number agreed to by CTT; and (iii) require payment of the license fee agreed to by CTT.
2. License Fee. The fee for the grant of the License pursuant to the General BCG License is paid by your Distributor, Aldrich Bonnefin & Moore, PLC ("Distributor"). The license fee for software modules other than those covered by the General BCG License are established by CTT from time to time and is paid by you to CTT, either directly or through the Distributor. A referral fee may be paid to the Distributor by CTT in connection with sales of the Software to you.

3. Restrictions. You may not: use, copy, or transfer copies of the Software except as provided for in this Agreement; reverse engineer, modify, decompile or disassemble the Software; or rent, lease, sublicense or assign the Software or any copy thereof, including any related documentation except only to the extent expressly permitted by law.
4. Maintenance and Support. CTT shall use commercially reasonable efforts to provide reasonable amounts of technical support for the Software at no charge to you. CTT shall have no obligation to provide technical support for any claim based upon (i) the use of the Software in connection with or in combination with hardware, software or data not intended for use with the Software; (ii) the use of the Software other than as permitted under this Agreement or in a manner for which it was not intended; (iii) any modification made to the Software by you or any third party; or (iv) if CTT has advised you to cease your use of the Software.
5. Term and Termination. This Agreement is effective for a period of three (3) years from the Effective Date as to any Software or licensed content accessible by you unless the General BCG License is extended by mutual agreement of Distributor and us. Without prejudice to any other rights, CTT or its distributor may terminate this License if you fail to comply with the terms and conditions of this Agreement. In such event, and upon expiration of this Agreement, you must destroy all copies of the Software and all of its component parts.
6. Copyright. All title and copyrights in and to the Software (including but not limited to any images, photographs, animations, video, audio, music, text and "applets," incorporated into the Software), the accompanying printed materials, and any copies of the Software are owned by CTT. The Software is protected by copyright laws and international treaty provisions,
7. Export Restrictions. You acknowledge that the Software licensed hereunder is subject to the export control laws and regulations of the U.S.A., and any amendments thereof. You confirm that with respect to the Software, you will not export or re-export it, directly or indirectly, to any countries that are subject to U.S. export restrictions. You further acknowledge that the Software may include technical data subject to export and re-export restrictions imposed by U.S.A. law.
8. Limited Warranty. CTT warrants that it has the right to grant the license set forth in Section 1 and that the media, if any, on which the Software is furnished to be free from defects in material and workmanship under normal use for a period of six (6) months from the date of delivery of the Software to you. Any replacement of the Software will be warranted for the remainder of the original warranty period or sixty (60) days, whichever is longer. EXCEPT FOR THE LIMITED WARRANTY DESCRIBED ABOVE, THIS SOFTWARE IS PROVIDED "AS IS" WITHOUT WARRANTIES OR IMPLIED TERMS OF ANY KIND, EXPRESS, IMPLIED OR STATUTORY, INCLUDING WITHOUT LIMITATION ANY WARRANTY OF MERCHANTABILITY, TITLE, NONINFRINGEMENT, THE CONDITION OF THE SOFTWARE OR FITNESS FOR A PARTICULAR PURPOSE. THE ENTIRE RISK ARISING OUT OF THE USE OF OR PERFORMANCE OF THE SOFTWARE REMAINS WITH YOU. CTT does not warrant the functions contained in the Software will meet your requirements or that operation of Software will be uninterrupted or error free.

9. Limitation of Remedies. CTT's entire liability and your exclusive remedy shall be: replacement of any software media not meeting CTT's Limited Warranty and which is promptly returned to CTT. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL CTT, ALDRICH BONNEFIN & MOORE, PLC, OR OTHER SUPPLIERS OR DISTRIBUTORS BE LIABLE TO YOU FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING BUT NOT LIMITED TO DAMAGES FOR LOSS OR PROFITS, FOR BUSINESS INTERRUPTION, FOR PERSONAL INJURY, FOR LOSS OF PRIVACY, FOR FAILURE TO MEET ANY DUTY INCLUDING OF GOOD FAITH OR OF REASONABLE CARE, FOR NEGLIGENCE, AND FOR ANY OTHER PECUNIARY OR OTHER LOSS WHATSOEVER), ARISING OUT OF OR IN ANY WAY RELATED TO THE USE OF OR INABILITY TO USE THE SOFTWARE, EVEN IF CTT, ALDRICH BONNEFIN & MOORE, PLC, OR ANY SUPPLIER OR DISTRIBUTOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL ALDRICH BONNEFIN & MOORE, PLC'S, OR ANY SUPPLIER OR DISTRIBUTOR'S LIABILITY FOR ANY DAMAGES OR LOSS TO YOU OR TO ANY THIRD PARTY EXCEED ANY LICENSE FEE ACTUALLY PAID BY YOU FOR THE SOFTWARE.
10. Confidentiality Obligations.
- 10.1 You agree that you will keep confidential any information or data ("Confidential Information") obtained from CTT in connection with this Agreement and shall not divulge the same to any third parties, except for: (i) information which, at the time of disclosure had been previously made public; (ii) information which is made public after disclosure to you; (iii) information which, prior to disclosure to you, was already in your possession; or (iv) information which, subsequent to disclosure, was obtained by you from a third party who was lawfully in possession of such information and was not in violation of any contractual, legal, or fiduciary obligation to CTT.
- 10.2 All Confidential Information shall remain the sole property of CTT. You shall have no implied licenses or other rights in the Confidential Information not specifically granted herein. You shall not disclose the Confidential Information to anyone other than employees and contractors with a demonstrable need to know, who have a binding, written confidentiality obligation to you that protects such Confidential Information against unauthorized disclosure or use. You shall take all reasonable precautions to prevent unauthorized use or disclosure of the Confidential Information.
- 10.3 You acknowledge that any unauthorized use or disclosure of the Confidential Information would cause irreparable harm to CTT.
- 10.4 Upon expiration or termination of this Agreement, you shall destroy all Confidential Information within three (3) days after the date of expiration or termination.
11. Governing Law. The laws of the Commonwealth of Pennsylvania will apply to this Agreement notwithstanding any conflict of laws doctrines to the contrary.
