## **CFPB Prepaid Account Rule**

n October 5, 2016 the Consumer Financial Protection Bureau issued the Prepaid Account Rule ("Prepaid Rule"). Under the new rule all accounts that meet the definition of "prepaid account" will be subject to Regulation E, along with several requirements specific to prepaid accounts. This includes two additional disclosure forms, an alternative error resolution procedure and limitations on liability for unverified prepaid accounts, and the submission and posting of all prepaid account agreements online. Initially the Prepaid Rule was set to become effective on October 1, 2017. However, after numerous amendments and a change of leadership at the CFPB, the Prepaid Rule is now scheduled to become effective on April 1, 2019 (unless further extended).

Our April BCG Telephone Briefing will provide a comprehensive overview of the Prepaid Rule in relation to Regulation E. We will also address the changes the rule makes to Regulation Z. Although the effective date is over a year away, the Prepaid Rule poses unique operational challenges and risks which financial institutions will have to understand and be prepared to deal with.
