### What Financial Institutions Need to Know About FFIEC'S New Cybersecurity Assessment Tool

Now more than ever financial institutions depend heavily on advanced technologies to conduct their business operations. However, with the advancement in technology comes increased security risk to the financial institution and its customers whose confidential information is frequently stored electronically. In July 2015, the Federal Financial Institutions Examination Council released its Cybersecurity Assessment Tool to help institutions identify and manage their cybersecurity risks. The Cybersecurity Tool is intended to provide institutions with a repeatable and measureable process to inform management of the institution's risks and cybersecurity preparedness. While institutions are not currently required to utilize the Cybersecurity Tool, regulators have indicated that the tool will be used in examinations to assess an institution's cybersecurity risk and preparedness against cyber threats. At this month's Telephone Briefing, we will discuss the Cybersecurity Tool, its impact on financial institutions and how institutions can utilize the tool.

### CFPB Supervision Observations on Private Mortgage Insurance

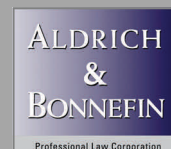
The Homeowners Protection Act of 1998 (HPA) dictates when a servicer may and must cancel private mortgage insurance (PMI) in connection with a residential mortgage transaction. Recently, the CFPB issued a bulletin in which it summarizes these HPA requirements. Just as importantly, the CFPB also shared some examples of when servicers have been found to have violated these requirements.
