lectronic banking provides innovative opportunities for institutions to reach their client base. This seminar will cover practical insights into some of the compliance concerns raised when providing financial services electronically. We will address the claims process as it is impacted by Regulation E, Visa and MasterCard rules, the National Automated Clearing House Association (NACHA) Operating Rules and California law. Some of the questions we will address include: When can an institution deny these claims and does it make a difference whether a claim comes from a consumer or a commercial customer? How does a customer's negligence in handling the card and PIN impact the claims process? What are the documents an institution can request, and how long does an institution have to complete its investigation?

Has your customer been a victim of email compromise or other types of fraud? Did it result in a wire transfer? As part of the presentation, we will look at the risks associated with wire transfer returns, including the risks an institution should factor into its decision to request a wire reversal (as the sending institution), or agree to honor a reversal (as the receiving institution).

We will also discuss the landscape of evolving "FinTech" opportunities and what it means to institutions from a compliance and legal perspective.
