ven though California has relaxed its laws with regard to the sale and usage of medical and recreational marijuana, the growing, usage and sale of marijuana remains illegal under federal law. Even financial institutions not providing financial services directly to marijuana-related businesses (MRBs) are affected to the extent these institutions provide services to non -MRB businesses which are in turn doing business with MRBs. To complicate matters, while hemp is no longer considered illegal as a Schedule 1 controlled substance due to the 2018 Farm Bill, the cultivation of hemp in California remains subject to regulatory oversight by California and, to an extent, the USDA.

Financial institutions are already seeing an increase in the number of MRBs as well as hemp businesses seeking financial services. There has also been an increase in disguised attempts by MRBs to obtain financial services, including by falsely claiming that their businesses are only involved with legalized hemp.

Join us for this Webinar as we discuss in detail the customer due diligence expectations and the potential risks to financial institutions in providing banking services to the hemp and marijuana industry. We will also provide some insights on navigating the regulatory licensing requirements for MRBs through the California Bureau of Cannabis Control.
