The California Consumer Privacy Act (CCPA) has been a moving target since it was first introduced in 2018. The statute itself was revised numerous times before becoming effective on January 1, 2020. Additionally, the California Attorney General proposed four different versions of the regulations before the Office of Administrative Law finalized the fifth version on August 14, 2020.

This one-and-a-half hour Webinar will address the more significant, practical aspects of the CCPA, including among others, what information is covered by the CCPA, how to comply with the CCPA's privacy notice obligations, and how to set up and respond to Requests to Know (RTK) and Requests to Delete (RTD). Additionally, we will discuss some current litigation trends and briefly discuss Proposition 24, "The California Privacy Rights and Enforcement Act" (CPREA) which will be on the ballot in November. There will be plenty of time for questions and answers.

Highlighted areas will include:

- ◇ What personal information is covered by (or exempt from) the CCPA?
- ◇ How do we prepare, deliver and provide the Notice at Collection and Privacy Policy?
- ◇ What types of data transfers are covered by the CCPA's concept of sale and how to stay within the "service provider exception"?
- ◇ How do we set up, verify and respond to RTK/RTDs?
- ◇ Must we respond to RTK/RTDs submitted by non-customers?
- ◇ What are some of the current litigation trends and claims filed involving the CCPA?
- ◇ How big of a change would the CPREA be from the current CCPA?
